## **Structure Governance & Management**

## Constitution

The Charity is an unincorporated association. It is governed by its constitution, which was adopted on 1 July 2010 and last amended 9 February 2011. The Trust was granted charitable status by OSCR on 28 February 2011.

## **Appointment of Trustees**

Trustees are elected at the Annual General Meeting, which normally held in September. Under the constitution, there must be a minimum of four and not more than nine elected trustees.

## Management

The trustees are responsible for the strategy, governance and the operational running of the Trust.

The fundraising committee, which includes all trustees, primary and only task is fundraising. The trustees are responsible for making decision with regard to the distribution of grants.

Decisions between meetings, on day-to-day matters, are made by the Chair and the Treasurer.

## **Objectives & Activities**

## **Charitable Purposes**

The Trust will provide grants to aid the sporting advancement of sports persons under eighteen years of age at the time of application for such grant, and who are resident of the TD1 postal area, and who would anticipate, and or, be experiencing difficulty in financing their future sporting advancement

The Trust recognises the ever-increasing financial burden of training and competing at the higher end of sport and will offer financial assistance to juniors who have shown proven ability in their sport.

Rowan fitted into this category and would have been a worthy recipient of assistance from such a trust and would have enjoyed the benefits he would have gained. The naming of the trust will ensure Rowan will be long remembered and he will leave a legacy across many sports in the Galashiels and Borders area.

The Trust will be funded through donations and fundraising events.

## **Activities**

The main activities of the Trust are to raise funds and then distribute them in form of grants to junior sportsperson to aid them in their quest for success.

## **Achievements & Performance**

During this, the second full year of the Trust the main aim was to capitalise on the good performance of the inaugural year and insure that the existence of the Trust in terms of its work and its need for funds is established in the local community. The success can be judged by an analysis of the £8,548 given in donations:

- 44% was given by 18 local organisations fundraising or collecting for the trust,
- Three lots of local people by organising events (head shaving, darts tournament & sky diving) raised and donated 24%
- The remaining 32% was straight donations by 25 separate individuals.

## **Financial Review**

The primary source of income during the year was donations, which amounted to £8,548.

There were five main fundraising events

- A sponsored cycle from John O'Groats to Galashiels,
- The sponsorship from a runner of the London Marathon,
- The sponsorship from a runner of the Great North Run,
- A rock evening held at the Volunteer Hotel Galashiels,
- A fun run round Meigle Hill which is an annual event.

The aggregate amount raised by these events was £7,836

Sales of wrist bands, Christmas cards, polo shirts, t-shirts and other branded merchandise amounted to £2,024. Purchases of these items to the value of £3,008 were made in the year.

The remainder of the year's total income of £20,284 included £6 in interest earned and £577 from running raffles.

The total cost of generating the income was £4,461. When the cost of purchases is subtracted leaves a cost of running the events and the administration of £1,454. The Trustees are grateful to the individuals and companies who donated there time, services and goods free gratis.

Ten grants aggregating £6,000 were distributed.

## **Reserves**

There are no restricted reserves and as the running costs of the Trust are low the only funds required, to be kept in reserve, are those needed to pay for up front costs of the fund raising events.

In the year 2012/13 the Trust intends to continue fundraising and increase the awareness of the existence of the Trust in order to raise funds and to increase the number of applications for grants,

- Run junior sports/fun day with coaching workshops in September 12,
- Hold a sponsored Starwalk in September 12,
- Support a sponsored cycle run from John O'Groats to Lands End,
- Hold a masquerade ball In February 13.

## **Independent Examiner's Report to the Trustees of the Rowan Boland Memorial Trust**

I report on the financial statements of the charity for the year ended 30 June 2012, which are set out on pages 9 to 11.

## Respective responsibilities of the Trustee and Examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) 2005 Act and the Charities Accounts (Scotland) Regulations 2006. ## 1. Basis of Accounting

These accounts have been prepared on the Receipts and Payments basis in accordance with the Charities & Trustee Investment (Scotland) Act 2005 and the Charities (Scotland) Regulations 2006 (as amended).

## 2. Nature and purpose of funds
